**Information Request #3 – Financial Responsibility of the Applicant
Line 21 Segment Replacement Project, Fort Simpson, NT**

Context:

As per section 35 of the *Waters Act* and section 32 of the Mackenzie Valley Land Use Regulations, the Mackenzie Valley Land and Water Board (MVLWB or the Board) may require an Applicant to furnish and maintain security. On September 29, 2017, the Government of the Northwest Territories (GNWT) submitted a security estimate to the Board. A response, received October 13, 2017, from Enbridge Pipelines (NW) Inc. indicated a general agreement with the estimate prepared by the GNWT.

At this time the Board has not made any determinations regarding security, or the applications in general, but as per paragraph 26(5)(d) of the *Waters Act*, the Board must be satisfied before a Water Licence may be issued that the financial responsibility of the Applicant is adequate for the completion of the undertaking, any mitigation measures as may be required, and closure and reclamation.

Information Request:

Please provide the Board with financial statements and evidence about previous performance of the company in the NWT, sufficient to show that Enbridge Pipelines (NW) Inc. has the financial capacity to meet the requirements of paragraph 26(5)(d) of the *Waters Act*. The requested information is due no later than **Wednesday, December 27, 2017**.
