

# Appendix I

## Updated List and Contact Information for Gold Terra Corp's Yellowknife City Gold Projects' Potentially Affected by Southbelt Amendment as of October 27, 2020 Version 7.1

This information was originally submitted on February 12, 2014, preparing for an application for a Land Use Permit for the Northbelt and subsequently approved as TerraX's Forward-Looking Engagement Plan Draft 3.0 following multiple rounds of consultation in 2013 and early 2014. At the time, it was noted that due to staff turnover, the anticipated devolution of responsibilities from the Government of Canada to the Government of the Northwest Territories, expected government reorganization and the continuing development of engagement protocols among affected parties that the Appendices to the Forward-Looking Engagement Plan and contacts would need to be updated.

The Forward-Looking Engagement Plan's Appendices were updated during the summer of 2016 in preparation for an application for a Land Use Permit for the Southbelt by contacting and consulting with the potentially affected parties. Draft 4.0 was circulated to the potentially affected parties for any additional updates in August 2016, resulting in Draft 5.1. Draft 5.1 was submitted to the MVLWB on November 10, 2016 and subsequently approved.

Version 5.1 was updated following engagement with the affected parties in April and May 2018, resulting in 6.0. Version 6.0 was shared with all stakeholders on June 1, 2018, resulting in an updated 6.1 on October 15, 2018, that was approved by the MVLWB. Draft 7.0 was updated on October 24, 2020, primarily based on advice received from the GNWT on October 20, 2020 and recent contacts with stakeholders during the ongoing engagement. Draft 7.1 was updated on October 27, 2020 to add information on reasons for changes to contacts from the Version 6.1 Engagement Plan as requested by the MVLWB.

Proponent contacts have changed as David Connelly has reverted to an independent consultant position, although he still provides services to Gold Terra. Joe Campbell remains as the primary contact for the proponent, but his position has changed to Chief Operating Officer.

MVLWB, Aboriginal Groups, Government of Canada, and the GNWT all remain as contacts in the Engagement Plan. Changes have been made to contacts within these organizations to account for personnel changes and internal organizational changes within these groups. For the GNWT responsible departments were determined based on advice received from the GNWT after a request by Gold Terra for new contact information.

A change was made to the City of Yellowknife contacts to move the city into 'Potentially Impacted Settled and/or Asserted Aboriginal Claim Groups and Municipal Governments' from 'Land Owners, Regulators' in the previous Engagement Plan.

Additions were made to include the Negus Point Residents. Although the project still remains outside their area the claim and lease additions bring Gold Terra's land holdings closer to this community and it is felt they are a potentially impacted group.
