Good Morning,

An update to the Online Review System for the [De Beers Canada Inc. - Snap Lake - Water Licence Renewal Application](#) has been made. Below is a copy of that update:

Please note that De Beers has submitted a Land Use Permit (Permit) Amendment Application for MV2017D0032 that supports the Water Licence (Licence) Renewal Application for MV2019L2-0004 (as noted in the [Application Package](#)) received on April 1, 2019. De Beers is requesting to amend:

- Condition 1: to allow for a temporary camp to be located at a new location.
 - o **Existing Condition:** *The Permittee shall use an existing campsite, as described in the complete application.*
 - o **Proposed Condition:** *The Permittee shall locate all camps on Durable Land or previously cleared areas.*
- Condition 50: to allow for an adjustment to the financial security and alignment with the planned activities associated with closure and post-closure phases of the Mine.

De Beers has also identified that the Licence MV2019L2-0004 Renewal Application included several updated management plans, initially distributed to reviewers on April 12, 2019, that apply to both the Licence and Permit. These include the:

- Final Closure and Reclamation Plan
- Engagement Plan V.2
- Spill Contingency Plan V.4
- Waste Management Plan V.4
- North Pile Management Plan V.3

De Beers has requested an exemption from preliminary screening, as per Section 1, Part 1, paragraph 2.1 of the *Mackenzie Valley Resource Management Act Exemption List Regulations* because the Proponent believes that the Closure and Post-closure are planned phases in the life of the Mine that were included in the original Environmental Assessment (EA1314-02) and the use of remote camps, both temporary and permanent were also included in the original Project Description and EA. If you have comments or recommendations on the possible exemption, please include them in your submission. INCLUDE RATIONALE. The Board will make a determination on the preliminary screening exemption on June 6, 2019.

Reviewers are invited to submit comments and recommendations using the Online Review System (ORS) by the review comment deadline specified in the [ORS](#). If reviewers seek clarification on the submission, they are encouraged to correspond directly with the Permittee prior to submitting comments and recommendations.

Please provide comments and recommendations on the documents listed above in the links provided in the [ORS](#). Reviewers may also wish to consider providing an overarching recommendation regarding whether they are in support of the submission, to provide context for comments and recommendations and to assist the Board with its decision.
