Good afternoon Philip,

Canadian Zinc Corporation holds several authorizations with the Mackenzie Valley Land and Water Board, and are required to pay annual water use fees as per requirements of Water Licences held by the company.

Andrew (cc'd here) with Canadian Zinc (NorZinc) is trying to pay for the fees using a credit card. Board staff have been directed to get Licensees to contact Financial Shared Services with the GNWT to pay for water use fees with a credit card, but Andrew contacted them and they were not able to process a transaction without some sort of invoice. The Board does not issue invoices for the water use fees.

Are you able to help Andrew get an invoice for the water use fees so he can pay Financial Shared Services, or direct him to someone who can help with this matter? Here is a summary of the fees he is trying to pay (through one transaction, if possible):

Licence MV2019L2-0006 (Board letter with details of fees [here](#))

\$118.84 – fees for the period of September 9, 2020 through to September 8, 2021

\$118.84 – fees for the period of September 9, 2021 through to September 8, 2022

Licence MV2020L2-0003 (Board letter with details of fees [here](#))

\$146 – fees for the period of February 12, 2022 to February 11, 2023

Licence MV2014L8-0006 (Board letter with details of fees [here](#))

\$1,091.35 – fees for the period of November 13, 2020 to November 12, 2021

So the total amount Canadian Zinc is trying to pay is \$1,475.03.
