Issuance of Quarry Permit located within the Giant Mine Remediation Project Site

This letter is to inform you that the Government of the Northwest Territories Department of Lands (Department) is issuing a quarry permit located within the Giant Mine Remediation Project (GMRP) site.

BACKGROUND

The last quarry permit that was granted within the GMRP site expired on August 5, 2022. The applicant is requesting to quarry 80,000 cubic metres of stone and 25,000 cubic metres of mixed sand and gravel which will be used for the construction of a new Water Treatment Plant and associated infrastructure. It is important to note that the Department previously consulted on the GMRP boundaries identified in this application on June 10, 2021, and that these same boundaries are not proposed to change.
