Andrew,

Paramount Resources Ltd. ("Paramount") is not comfortable providing easily editable documents to the public registry. Paramount reluctantly provides unsecured documents (PDFs) for the public registry to assist the MVLWB and reviewers. Paramount in the past has provided feedback relating to board guidelines and processes noting concerns with document security (see email below as an example). Paramount notes the *LWB/GNWT/CIRNAC Guidelines for Closure and Reclamation Cost Estimates for Mines* you refer to state:

"These Guidelines can be used to inform closure cost estimates for projects which require a water licence but are not mining, milling, or advanced mineral exploration projects (e.g., oil and gas projects<sup>7</sup>); the Boards' processes and expectations for closure cost estimates will typically be the same as those outlined in these Guidelines."

Can be used and typically provide space for our request in the opinion of Paramount Resources Ltd. of posting the security as a PDF, which would be consistent with all other documents that

Paramount submits to the MVLWB. Why does the MVLWB want the document in Excel (other than allow others to edit the work of Paramount)?

The ESAs are part of the CRP so Paramount expects them to be posted. Your question again highlights Paramount's concern with breaking up documents for ease of review. A PDF of the security estimate is attached for ease of reference.

Ultimately, a copy of the closure cost estimate will be distributed as part of the public review for this submission (once deemed complete) to allow reviewers to understand Paramount's position and provide evidence.

Please also clarify whether Paramount is requesting that the ESAs be kept off the registry and why.
