Enbridge Pipelines (NWT) Inc. (Enbridge) is hereby submitting a notification for a temporary camp that will be used as part of the integrity dig operations and maintenance program in the Dehcho area located approx 30km north of Wrigley. The temporary camp will be located at **KP 285**, as approved under permit MV2020P0006. Occupancy at this temporary camp will be 28 people or less. Snow clearing at the camp site will start January 21, 2021 with camp trailer mobilization following shortly thereafter. Once the camp and work on the ROW begins, it will operate through Feb, and early march. Teardown and demobilization to be completed before March 15. Periodic updates on camp construction progress can be provided.

Actual Estimate of Fuel Storage for this year:

All propane tanks on site are going to be sized identical this year to 420-Pound vertical tanks (2 per trailer) x 12 (trailers) = 24 tanks x 378L per tank = 9,072 Total Litres of Propane Storage on Site.

For diesel, we intend to have 1 main diesel tank of 44,000 liter capacity. This will be the largest tank on site. The generator will have 1 tank of 2,500L diesel capacity.

For gasoline, we are still trying to determine the overall capacity, but we can easily assure that the total volumes will be less than 44,000 liters. We can provide updates as they become available for the exact size of the gasoline tank.
