Re: Husky Oil Operations Limited – Letter of Clearance – Sah Cho L-71 Wellsite, Sump and Camp – EL 397 – 50 km SSW of Tulit'a, NWT

The Sahtu Land and Water Board (the Board) met on November 16, 2021 and reviewed the file for Land Use Permit (Permit) S04A-006.

The Board received a Final Plan for this land-use operation on January 25, 2020.¹ Subsequently, an Inspector conducted a final inspection indicating satisfaction with all aspects of the operation and recommends closure of the file.²

Final Plan - Approved

The Board has approved the Final Plan because it fulfills the requirements set out in subsections 29(1) and 29(2) and section 30 of the Mackenzie Valley Land Use Regulations (MVLUR).

Fees

The Board notes land use fees in the amount of \$760.00 were submitted with the application, including the \$150.00 non-refundable application fee and \$50.00 non-refundable assignment fee (Receipt

#C105349³). Having considered the Final Plan, the Board has verified the land-use fees pursuant to 31(1) of the MVLUR for this land-use operation as follows:
