MGM Energy has been undertaking monitoring and progressive reclamation treatments for the past decade, the results of which have been provided to the Sahtu Land and Water Board and are available on the public registry. The only infrastructure to be removed from the sites is the wellheads, which will be removed after the completion of the downhole abandonments. Reclamation techniques are expected to stay within those used for the last decade.
