Subject: Plans for 2017-2018 Fiscal Year

Nahum:

Just a short note to advise you of our current plans for this fiscal year:

I am coordinating with Eric Andert of BluMetric to return this Spring to complete the construction of the new Land Fill. We have budgeted for a private contractor to complete the project as opposed to trying to use our own forces.

Further, Eric will assist us in the closure of the old Land Fill, and provide guidance on the remediation and eventual closure of the Land Farm.

I have it noted, from our meeting in February, that you will need As-Built Drawings and Fencing Installed 30 days prior to putting the new Land Fill into service. In reality, I would appreciate you occasionally dropping by to monitor construction progress.

I have Michel Lanteigne of AECOM focusing on the raw-water inlet issue for Edzo, so I will probably capitalize on BluMetric to address a few immediate lagoon concerns (Rae - berm subsidence, Edzo - #3 Cell, Edzo – fingers)

Finally, I am pleased with the support of Council insofar as budget is concerned. We were able to commit funding for the following projects for this coming fiscal year:

- 2017 & 2018 Rae Lagoon (over 2 years)
- 2017 & 2018 Edzo Lagoon (over 2 years)
- 2017 Old Land Fill closure
- 2017 New Land Fill Opening
- 2017 Land Farm Aeration & Closure
- 2017 Raw Water Supply Study for Edzo Water Treatment Plant

As a result of our discussions in February, I want to make up SNP location signs, similar to what Whatì added, and have those ready to be installed as we resume SNP sampling this Spring.

Thanks for everyone's positive support in getting Behchokò back on track. We recognize that we still have lots of ground to cover yet, but we are going to make progress in 2017/2018.
