Re: **Northwest Territories Mining Recorder's Office Consent to Transfer Mining Leases to Arctic Canadian Diamond Company Ltd.**

Please accept this letter from the Northwest Territories Mining Recorder's Office (the "**MRO**") confirming our conditional approval of the transfer by Dominion Diamond Mines ULC ("**DDM**") to Arctic Canadian Diamond Company Ltd.
