Solid Waste Comments:

Both solid waste facilities were inspected (Photos 4-6). It appears that regular household waste items are being disposed of at the construction waste and bulky waste disposal area on a regular basis. Regular house hold waste items must be disposed of at the trench disposal area during future operations.

The bulky waste area requires better segregation of waste types and the area must be covered to prevent windblown waste from being scattered.

General Condition Comments

It is noted that Part H, Condition 1 of the Licence states:

The Licensee shall annually review the Operation and Maintenance Plans for the Sewage and Solid Waste Disposal Facilities and shall submit updates to the Plan for approval at the following times:

- a) When necessary to reflect changes in operation or technology; and
- b) Upon the request of an Inspector or the Board.

The Operation and Maintenance Plan has not been updated since the completion of the Tłįchǫ All-Season Road (TASR). In the WLWB's Reasons for Decision, it directed the Community Government of Whatì to update the plan no later than one year once TASR had opened. The Inspector requested that the Community Government of Whatì submit an updated Operation and Maintenance Plan to reflect operational changes that have occurred after TASR opened by December 31, 2023. The plan is still outstanding. A reminder email was sent by the WLWB on April 22, 2024. Please submit this update to the Operation and Maintenance Plan.

NON-COMPLIANCE/VIOLATIONS OF ACT OR LICENCE

1. Part B, Condition 4: The Licensee shall comply with the Surveillance Network Program, with is annexed to and forms part of this Licence, and any amendment to the Surveillance Network Program as may be made by the Board.

Explanatory Remarks: The Community Government of Whati has not submitted any SNP Sample results to the Inspector. SNP Sampling must be conducted in accordance with Annex 1 of the Licence.

2. Part D, Condition 11: The Licensee shall dispose of all solid Wastes at the Solid Waste Disposal Facilities in accordance with the approved Operation and Maintenance Plan for the Solid Waste Facilities.

Explanatory Remarks: Although there was still a significant amount of snow cover, it appears that the construction waste disposal area is being used for the disposal of regular household wastes. All regular household waste items must be disposed of in the trenched disposal area and the area of concern is reserved for larger waste items and construction waste.

- **3.** Part H, Condition 1: The Licensee shall annually review the Operation and Maintenance Plans for the Sewage and Solid Waste Disposal Facilities and shall submit updates to the Plan for approval at the following times:
 - a) When necessary to reflect changes in operation or technology; and
 - b) Upon the request of an Inspector or the Board.

Explanatory Remarks: The Inspector had previously requested that an updated Operation and Management Plan be submitted by December 31, 2023 to address operational changes that have occurred since TASR has opened and to address Board direction. This report has not yet been received by the WLWB and a reminder email was sent on April 22, 2024 regarding this requirement.
