Hi Denise,

To reiterate our discussion on the phone, the current submission by Nighthawk does not align with the Applications submitted to commence these proceedings nor the evidence provided by Nighthawk during the various steps of the process (e.g., NHK stating there would be no open pits or declines). The current process step to re-open the record to seek clarity on elements related to security was/is not an opportunity to further expand the scope of what Nighthawk has applied for and committed to. This submission cannot be accepted in its current form and must be either revised to align with Nighthawk's application, or revised Applications must be prepared and submitted.

I'm not clear on what questions Nighthawk has at this point, but since a submission has been made to their WLWB Board staff can only speak to questions related to process. If Nighthawk could articulate its questions in writing so our team can confirm whether it's appropriate for us to even discuss those, that would be a recommended first step. Your timely attention to this matter is appreciated as the Board is bound by legislative timelines and in the near future the WLWB will need to continue towards the completion of this proceeding to ensure those timelines are met.
