Hello SLUPB,

Thank you for the opportunity to comment on the Background Report for Amending the Sahtu Land Use Plan

Please find attached a track change document on the report itself and a couple of comments on the maps.

Comments on Maps

The map on page 2 refers to park boundary information supplied by "Parks Canada, 2012". The boundary shown however is not the one announced in 2012. It should reflect the shape files from 2014, which we hope you have. If so they the caption date should be 2014. (I see the same date for the boundary on other maps, on pages 12 - 16.)

The "Interim Land Withdrawal" boundary shown on maps on pages 12 - 15 is not correct. The line shown on these maps corresponds to the PCI, which was the ILW with an additional area for O'Grady Lake. The PCI boundary would include an area slightly larger (c. 20 sq. km) than the 7,600 sq. km of the ILW. The boundary option maps on page 8 show the correct ILW boundary.
