Good day Tim and Kim,

This is to notify and inform the Inspector and Board of a number of temporary changes related to the Giant Mine Remediation Project and the requirements under Water Licence MV2007L8-0031 and Land Use Permit MV2019X0007.

Due to the changing conditions in the Yellowknife area from wildfires, and the local and territorial issuances of a State of Emergency, the GMRP is notifying:

- -The Annual Geotechnical Inspection (AGI) of Dams scheduled for the week of August 21, 2023 has been postponed until further notice.
- -All regulatory monitoring at Site is suspended immediately until further notice.
- -All remediation work at Site is suspended immediately until further notice.
- -Basic care and maintenance may continue, if, and as, safe to do so.
- -Compliance with emergency assistance requests from the City of Yellowknife and GNWT, as and when they occur, including equipment and potential storage of explosives at Site.
