**Issuance of Quarry Permit at Km 310.6, off NWT Highway No. 3**

This letter is to inform you that the Government of the Northwest Territories (GNWT) Department of Lands is issuing a quarry permit at Km 310.6, off NWT Highway No. 3.

**BACKGROUND**

A quarry permit has been applied for at an existing quarry located at Km 310.6, off NWT Highway No. 3. There is an existing access to the quarry and the application is for 50,000 cubic metres of bedrock/blast rock which will be used for ongoing operation and maintenance of the public highway. The last quarry permit issued at this site was Quarry Permit 2018QP0016 which has been closed. It is important to note that the Department of Lands previously consulted on the quarry boundaries identified in this application on February 12, 2018 and these boundaries are not proposed to change.
