Hello Roberta, Patty, Heather, David, Clint and Brandon,

Beginning on August 15 NTPC will begin work on some maintenance projects at Snare Hydro under water licence N1L4-0150 and land use permit W2019Q0003.

The maintenance work will include three tasks; each task is outlined below:

Maintenance and repairs for Snare Forks Dyke 1

- Install a 120m x 2.3m silt curtain along working face of Snare Forks Dyke 1 in the Snare Forks forebay before earthworks take place
- Remove Riprap from the northeast face of Snare Forks Dyke 1 and stockpiled
- Excavate glacial till from Snare Forks Till Pits
 - As outlined in W2019Q0003 recent amendment minimal vegetation removal will be required but any vegetation or topsoil removal will be completed in accordance with amended W2019Q0003 requirements
- Haul material from till pits to Snare Forks Dyke 1 and place on upstream face
- Replace riprap on the dam face
 - Some additional riprap may be added as required from previously quarried material in the Snare Forks quarry

Maintenance and repairs for Strutt Lake Dam

- Strip organics from left toe area on downstream side of dam

- Haul & place 20mm crush stone from Forks quarry stockpile to toe area.
- Sort, haul n place rockfill from Forks quarry to toe area.

Airstrip Dust Control;

- Previously approved dust control product will be added to airstrip using a water truck
 - I don't have access to the system right now but we obtained approval from Nahum on the dust control product in 2018/19

Clint and Brandon please accept this as the formal notification that work will begin under the permit on August 15, 2020. If this date changes I will contact you.
