Direction: MGM Energy Non-Compliance with Letter of Decision Requiring the Submission of Well Approval Applications for the Abandonment of Nogha C-49 (WID 1934) and West Nogha K-14 (WID 2006) Wells (OA-2019-002-MGM)

On August 20, 2019, I issued a letter of decision in response to an application from MGM Energy (MGM) for an extension to the deadline for bringing the Nogha C-49 and West Nogha K-14 wells into compliance with the Well Suspension and Abandonment Guidelines and Interpretation Notes. The letter of decision approved an extension for the abandonment of these two wells to April 1, 2021 and required that MGM submit applications to Alter the Condition of a Well (ACW) for these two abandonments to OROGO by noon (MT) on October 31, 2019.

To date, I have not received the required ACW applications.

I hereby direct MGM to submit complete ACW applications for the abandonment of the Nogha C-49 and West Nogha K-14 no later than noon (MT) on November 15, 2019.
