Application for Waiver of a Benefits Plan

Aurora College has previously indicated that it “attempted” to submit a request for a waiver to the Minister on February 5 or 6, 2023.

As Aurora College plans to begin operations with gas migration testing on July 16, 2023, it is imperative that Aurora College provide confirmation of the Minister’s decision on its request to waive the requirement for a benefits plan.

Request:

Submit confirmation of the Minister of Industry, Tourism and Investment’s decision in response to Aurora College’s application for Waiver of a Benefits Plan.

Response:

Aurora College received acknowledgement of ITI’s receipt of the Benefits Plan Waiver application on June 5, 2023. The application was apparently sent to an email address that is no longer in use by ITI.

Minister Wawzonek has assured us that ITI will action our request as soon as possible noting the start of the summer work season. Subsequently on June 6, Assistant Minister Strand contacted us to provide assurance that officials from ITI are actively working on our application package noting our timeline.

We apologize for not following up with ITI when we did not receive confirmation that they had not received our application.
